**Page 187-189** 17th of March 2013 this is an email from me to mark Upton and it says the police have a dishonest way of grabbing me and trying to put me in jail. Oh it is also being copied to Mr Clarke so must have thought I'm rubbish.  
It seems to describe among other things the incident where police came late in the evening when I was talking to Regent on Skype.

**Page 190-191.** This email was also sent by me on 17th March 2013. It was sent to Mr Clark from the email address vwortley@hotmail.com . This all email also sees my parents been trying to kill me for decades and describes the late evenings instant of police arrival.

**Page 191-219:** On the same page the email to Mrs Macaulay seems to start. Since it doesn't have a date or any email header, I think it is the text of the Macaulay email above which is being copied. This is also very long and I don't think it is a verbatim copy of the email to Mrs Macaulay above. I did send only one so I don't know really what they are. They are both the messages sent to Mrs Macaulay. My signature appears on page 219

**Page 220:** This sentence an email by Alex to Mr Clark on the 19th of March 2013. The police were coming to the house at Strange Times and this was reported to Mr Clark. Alex and I had requested Mr Clark to take charge of the matter. A Mr Clark had said he does not know how to call Uxbridge police station. We found it surprising that a lawyer does not know how to call a police station and I told Alex that he could be lying. This is the helpful email of Alex to Mistral Clark with Oxbridge Police Station number or how to contact the police station

**Page 221:** Photograph of a ticket to Graves and Mr Clark's office on the 27th of March 2013

**Page 222:** A National Express bus ticket from London to Birmingham on the 5th of April 2013

**Page 223-226:** This is my email, sent from mohini home7 and from mohini Yahoo on 10th April 2013 to Sean kabatof. The email says how can I get parliamentary punishment? I vaguely remember parliamentary punishment and somebody saying that soul I can't remember the whole story. Sean did not reply. I don't know if he's alive in Canada or was alive in April 2013 he just disappeared when I first. To the UK like 2006 or 2007 Alex email Sean kabut off pretending to be a female Smith and that time Sean replied with his religious beliefs. After that he never answered and didn't answer me. There was one occasion probably 2006 or something like that. Maybe it was when I joined bnp. He said he hated me for the action and had unfriended me on Facebook that's what I remember so it must be 2011 or 2012

Anyway I've seen to have written to him in 2013 and he didn't reply. It useful to read this and also the other um type material life created to see if it tells some of my story or has effective testimony to add in my book, or a testimony

**page 227-228:** A letter from Ali Lindsay solicitors dated 11 April 2013 . I want to read the letter again to see if there is anything rude contemptuous or suggestive of mental incompetence. It simply says I came on second April and I paid 50 pounds. It tells the story I told them briefly

**Page 229:** This is a letter from Ally Lindsay solicitors date and second April 2013. It is just an invoice

**Pages 230-232:** A testimony I have typed Rich has been counter signed on each page by

Alex. 18th of April 2013

**Page 233:** An email Exchange by me as vwortley@hotmail.com with Nick on eight of March 2013. It's a letter that sort of tests in pretending to be with you. He replies and he clearly shows that he sees me as garbage.

**Page 234:** This takes us to 24th and 25th of April 2013 when I was detained that pacing Stoke police station. There are four sheets of paper which look identical except for a couple of items. They all say the word foreign Force about five times. I suppose the police lady does not want anyone to miss the fact that I can be deported.

Page 234 shows us having been created on the 24th of April at 1059am and the signing officer is called Potter. Time of arrival 1020 am. **Page 234** was printed on computer BBC us02 and 1059 a.m. 1 of 24th of April. At the bottom it says page one of two

**Page 235** was printed on computer BBC us02 at 120 pm of 25th of April. At the bottom it says page one of four.

**Page 236** is a photocopy of page 234

**Page 237** is a photocopy of page 235

So it looks like I don't have page two of two which which is the second page of the two page document beginning on page 234

And I don't have pages too three and four of the 4 page document beginning on page 235.

So they didn't give me the full documentation which I probably had a legal right to

On page 238, and a few more pages, there is handwritten material by me. This I wrote When I Was detained overnight.

What I have here maybe only part of what I wrote. I'm going to read out what I wrote because my handwriting is you know slightly faint and it is easier like this using AI speech to text:

So my parents moved their location from San Francisco to a mortal run by Indians in Tucson. The obtained as an Ally an Indian doctor along with three US doctors wrote False statements to a judge that they had seen me and I was gravely disabled and small to the judge the hearing could proceed without me being present because I was incapable of understanding the proceedings. **Page 271-275** this is an email I sent to a large group of people. On top it says VU2KV but it was sent to a bunch of people including VU2KV . It starts with hail Hitler the pig is dead . I appear to have sent a copy to Tim Pearson. Well it does say I'm going to die which is not that bad as a message to them but i'm sure he hated very nasty person

**Page 276-279 .** 2 June 2012 This email is addressed only to region exiter and nobody else. The subject line of the email is having the humility of a cellar prostitute. Previous email was addressed to multiple people including VU2KV. It had my father's name, VU2KV, on the top left of the email. Well he was one of the recipients, but why is his name coming

upon top? It would obviously see that it was printed out on his computer. This current email was addressed to Regent and nobody else so why is it coming out on kv's computer. Since KV has previously shown ability to hack, I would assume that he was hacking my email and intercepting what I sent to Regent. When I spoke to him in January and February this year he was Furious that I taught here hacked my personal communications. He said he knew nothing about it. Well I believed him considering how Furious he was. I also been traumatized during the conviction and will on both these emails there is an email address on the top right side of the email. I mistakenly thought it was his letterhead. Actually it is an email address and it belongs to our member of Basingstoke police who has been identified by his or her badge number. My father's name via 2kv appears on the top left and one should still assume that it was printed on his computer.

An email sent to him could have been printed on his computer. Since it was printed on his computer he gave it to viju. Did he give it to which when they were talking and they are good friends, or did he give it to which you to use to charge me? If he gave it to viju to use to charge me than he is involved in it

Since the email sent only to Regent Exter was printed from his computer I would say he hacked it which is not supposed to do its my private communication to who subsequently died under Foul Play.

Since KV when he was alive denied hacking my email, I wonder if he could be telling the truth

If he admitted to basing stock police that he hacked my email, they obviously approved of the unlawful activity. Since it was a private communication to a friend and not connected in any way to which it is not usable as abuse and it is not a thing she can complain about

This has on top the fact that it was faxed on my 19th March 2013 at 1737 hours from bbenofax to 2 5 4 9 2@hantspol.gov.uK

It also says page 10 by 27. This suggests that the facts had 27 pages. Of these are communication sent by me. There is no email header so we don't know who it was sent to. Although it may say something they don't like: Racism and gangs in the NHS: I'm sure they're not going to like that- but it is not a harassment of viju wortley

The first two are emails sent by me. The first a group email. The second a private one to Regent Exeter. Well my messages are hated by the British society but in neither case was Viju a recipient.

This communication one **gangs in the NHS** the header is deliberately cut off. I mean it would have been sent as an email or a letter and if they publish the whole thing and we would know who it was sent to. Certainly they wouldn't like anyone saying there are gangs in the NHS. However I am pretty sure it was not sent to Viju Wortley. I pretty much have a pattern to what I do I am logical and I am not incoherent although they may hate me

There is a date on top of the message 28 September 2011

**Page 282-285:** 4 February 2011 This is another sample of my Communications. It has been sent to only two emails belonging to my father and one email belonging to Thames valley police. I've sent something to an editor of a newspaper too but I don't think they were interested. They had not solicited and my communication so they probably did a true away the email. The reason it was sent to terms Valley Police is I knew that person's name and he had already contacted me.

In 2010 my father made a fraudulent missing person report of me. I hate to say this because he has passed away and we're all going to pass away one day it doesn't mean I should be accused of things I haven't done. So when my father made a fraud and missing person report he knew where I lived and it was Alex who would tell the police if I was missing but he made out to the Indian Court that living with him living with my parents and this person PC Verde sent me an email sounding like an email written to a moron and then went on long leave conveniently.

The case was taken by Phil is and of course he's English and that's the person who I was addressed the email along with my father so this is an ongoing discussion with my father because I'm offended that he made a fraudulent missing person report.

So all these things that you see are connected to dispute with my father and it was not sinned to Vijay there were some comments maliciously made by video and I had written to her to stop harassing me so was one letter now they don't want to display that what she did is she scanned it and then removed my name and signature and said that I sent it anonymously I don't send anonymous letters I don't joke if I want to say something clearly to someone to stop her see me or do it with my name my address my everything I don't do these things on the sly

It says if I am not allowed to talk to non women I will die

I mean they make a huge thing out of it and say I am in coherent andmentally incompetent

But it had nothing at all to do with vijuently

And if you look at the communications some of them just hardly anything offensive except I've used some phrases which are really hate like racist anti RAC hate those

On page 285 list of documents that I owned and I must have sent it to my father and the cop feel Isles.

Maybe that is viju's phone

again we are still on communications that were faxed on the 19th of March 2013 from B benofax (whoever that is) to 25482@hantspol.gov.uk, and we are on page 16 by 27

I guess the pages are going in serial order but we started on 10 at by 27. So pages 1 to 9 by 27 have been concealed. They were not given to Thomas Simpson solicitors

So this is 5 page document. It is dated 29th of September 2011. It is written to me by the Pembroke mental health center. I was living with Alex and this mental health center is closest to his home. I had made a complaint through 2011 of harassment by Pembroke mental health center. When he would go to work they would come and bang on the door and it became very frequent. I had a legal right not to open the door but and I was informed I knew I had a legal right but it became very aggressive and very traumatic to have them all the time. The other thing was that they were copious male sent to me by the Pembroke mental health center. This male started in 2010 and throughout my stay in the UK as long as I lived with Alex I was getting this kind of male from them;. Again I had been told of my legal right to refuse so I even a solicitor told me about it once so I just ignored it. Throughout my stay in the UK when I was living with Alex, I must have received a appointment with 40 different psychiatrists. I did not attend I did not answer the communications. There were other communications as well not just a appointment to psychiatrists. The large number of psychiatrists I was given on appointment with indicates that they have more professionals damn patients and don't know what to do with themselves. Anyway maybe you can understand they were very very insistent and aggressive so if they had had a legal right they would have grabbed me and forced me who are they? The Pembroke mental health center.

Okay I have a huge binder of their communication somewhere. Chances are Alfa find it and it is in PDF format

This proves I told the truth about their copious Communications

Kicking and banking the door after Alex went to work became a regular feature

It was like not see Germany it was like one of those horrible things that used to happen because people say go to the police. But the police was in kahoots with the Pembroke. Who was behind this abuse?

Pembroke staff do not have any qualifications such as doctor or nurse. They are course individuals and the mental health center caters to of course drop in mental patients but also to offenders release from prison drunks and anybody that could use a ten pound note a sandwich and a coffee

Well the Pembroke has cypat is visiting from time to time to see these people hence they were able to send a appointments

Because they are manuals that means they do not have the of the police or of the Medical Profession. I suppose somebody has to give them permission or a green signal to come and kick the door

The point is I wouldn't know but I assume it is the Medical Profession or the police the law enforcement

I don't want to keep it very lengthy but it wasn't the Medical Profession. My GP had nothing to do with it and they were very aggressive with banging the door right up to the middle of 2011

One incident in the police came and kicked the door and actually broke the door you can't be a admitted responsibility. To keep along story short, I think they were breaking their own laws and they did not have a right to do such a thing. Through God's blessing I was not at home when they broke the door but the next day was reporting Dave and I was upgraded from is one five one eight i s 151b

So I have told you the story of pembrokes harrassment and how it was terrifying and persistent and disrupting life but there was no law that could protect me against it

I wanted to repeat that my GP or the Medical Profession had nothing to do with that you don't have to believe that's my statement and they would tell you as well

Yes in 2010 my father did make a malicious referral to mental health services and made a fraudulent missing person report using an Indian Thames valley police PC wordy who later went on long leave so that he could not be reached for comment

At the bottom of page 296 it says copies were sent to nine other people plus Mr V and RG31 7zn. I'm referring to my father then because that's his house and I've written Tim Pearson. I'm not completely sure but I mean trying to believe it is my handwriting

Pages 10 to 27 of 27 have been faxed, the one to nine have been concealed, in the file given to Thomas Simpson solicitors is I believe he gave me the whole fight

But there is more to come the facts on 19th March 2013 continues from Bbenofax to 25482@hantspol.gov.uk hillary

The first page 299 says 46 by 60. I suppose the first 45 pages have been concealed and pages 46 to 60 have been given to Thomas Simpsons Solicitors

These are communications sent by me but they have been rotated by 90 degrees and I'll have to read it I'd have to rotate it to see what it is . It's lengthy and exhausting

On page 301, which is page 48 by 60, it says the police September can my parents tried to kill me

Well what happened is I stopped my father to stop making these malicious communications and I said over the phone bastard stop calling them and in fact the UKB alleged that he said to deport me and Lock me up so anyhow I was very upset over that

So the police would come and arrest me and make me go to a and Eve and I told my father bastard stop calling here

I would wait all day and the a and you would take my blood pressure and Release Me

I mean the police wanted the medic to section me but they did not

So they did not do exactly what the police wanted

Anyhow to cut along story short, I felt that if I want in my father to stop communicating in this way or I would kill myself, it would be a good idea for my father to stop. If he did not, he was taking a risk of me killing myself. Now because my father was saying I was mentally unstable, if he believed what he was saying, he should know that there was a greater than average risk of me killing myself. So he should take caution and not go call people all over the place about me.

I guess the police the Pembroke and my father taught that he could keep on calling me and calling people about me and to lock me up if I try to kill myself

That's why I said they all want to kill me because they're so interested in my mental health that they want to keep the relationship going even if it causes me to kill myself that is what I was trying to say

No if you look at the communication given on page 286-2 created 29th of September 2011, you can clearly see that my parents are trying to use psychiatry through the Pembroke to try to average and chip with me

The other thing though is that when I did actually take an overdose the hospital acted very strangely and if Alex had not put the oxygen back that night I can't say I think I might have died I know people don't believe it but they wrote all kinds of lies in the report you would and believe what they did so I concluded that I had to be literally whipped into obeying my parents are in otherwise I deserve to die and they were going to do it and nobody was going to know you know

So that is what is written in that communication

It is making an allegation against them all including the police and I'm sure they don't like the allegation. They may know the allegation is true or they may not but certainly they're not going to like it right

**Page 314:** Comments by me

**Page 315-320** again a lot of lengthy stuff. I am getting tired with my own stuff so others will do. Firstly I think you noticed that I pleaded innocent on the charge sheet where I wrote what I actually did as opposed what I was accused of. The date this took place is 24 than 25th of April

Next I received a file from Thomas Simpsons citizen 29th April. That's the file I was coming on the pages of. In this letter of 2019 April he states that Ali Lindsay is my solicitor. She said since I didn't pay aliens say had already got legal aid

Not very long after, which is the next day, 30 April 2013, I am emailing basing stock Magistrates, explaining what has transpired between me and my solicitor and he's putting pressure or going in a direction that I do not agree with

On the last page of the email, on the last but one line, I am asking the basing magistrates Court

So is there an order from the court that I am barred from appearing in court unless there's a mental assessment from a psychiatrist

You see now that I jog my memory cells, I remember phoning the court and asking them if such an order exists because my solicitors are claiming that. The court answered there was no such order and you can certainly appear in court

I wish I had taped the solicitor which I was little told but unfortunately I did not foresee this and I did not understand the basic things like going on trial pleading guilty and so on I did not have a full understanding of it

Because my legal representative Ali Lindsay Mr Hitesh Keshwala lied to me that I was bored from appearing Court unless I saw a psychiatrist I felt that he was hateful and unhelpful towards me

Maybe if I was genuine the mentally incompetent I would run off and see a psychiatrist and Mr keshwala kulp to the court that I'm indeed a mental patient

Anyhow I was very traumatized and like the email shows he was twisting things a lot and very very tired

Did not know the meaning of terms like going on trial and things like that I'd never been familiarized with criminal proceedings before

The communications which I'm allowed to have sent seem to refer to my saying to my father hail Hitler the pig is dead and then Ellie Lindsay says why don't you please guilty and you know you will get a small punishment and get away otherwise you're gonna get a big punishment and then I agreed you know but there was an email sent before that the end that I had agreed to that that it could be become a harmless thing as soon as I said I'm guilty and he said don't say anything other than guilty you know you must obey me or I was in such a lot of stress you know so this communications I also refer to how early means they told me that if I didn't have a head assessment I would be banned from appearing in court and I refer to his comment as well and I referred to a number of different things so anyhow it's not an email or you know doesn't seem to be proof so right then I was uncomfortable with it and I also email the court that the solicitor is telling me that I'm band if I don't have a head check
