Your Irish Residence Permit:

- ☒ Shows your photograph and your personal details, the type of permit or stamp you have and outlines how long you can stay in Ireland.
- ☒ Is for your **personal use** only, and you must always **carry it with you** and show it to the authorities if asked.
- ☒ Once your permit is **valid**, you may leave Ireland and **re-enter the State** without the need for other immigration-related travel requirements, such as a visa. However, you must bring your IRP with you when travelling.
- ☒ It does **not** allow you to **travel freely or live elsewhere** in the European Union or the European Economic Area.
- ☒ It is **not an identity card**, but it is an important document proving you have legal permission to remain in Ireland.



Please note

When you registered your permission, we noted your **current address**. If this changes, you are legally required to let us know at immigrationsupport@justice.ie

If you **lose** your IRP card or if it is **stolen**, you should **report** it to An Garda Síochána immediately. Check www.garda.ie to find your local station. Once you have an official report of the incident, you can contact immigrationsupport@justice.ie and we will verify your identity and documents before issuing a new card.

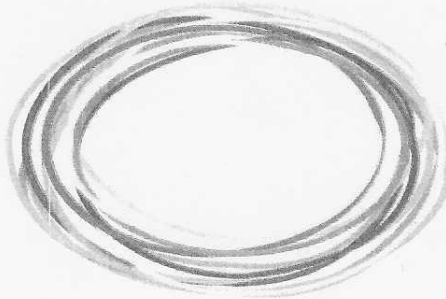

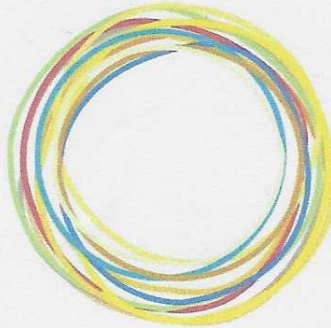

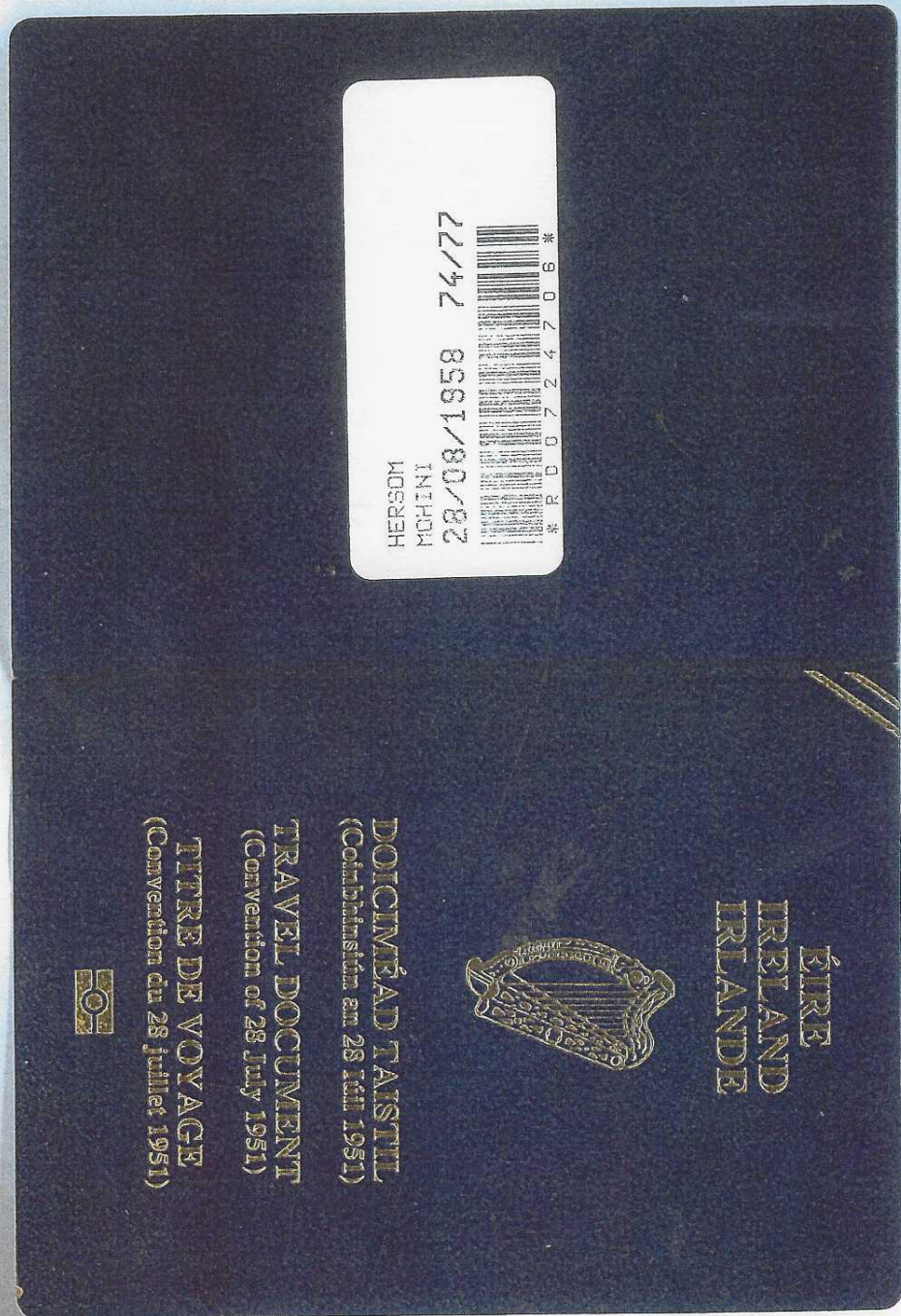
