Statement by Mohini Hersom about how Viju has used the injunction to exert undue influence.

MOTHERS DEATH

I had made an immigration application to stay in Ireland, which was still pending, when my mother died, on 22 February 2022. Was grief stricken but I could not go to England to visit and attend my mother's funeral, because people who make an immigration application void their application if they leave the country. I had taken voluntary departure to Ireland because I felt the UKBA might deport me to India based largely on the harassment without violence charge issued by Viju Wortley at Basingstoke Magistrates on July 13 along with her injunction

I could not tell my father I was in Ireland, because previously when I was in Canada and the US, my father repeatedly called offices in those countries and even visited there to sabotage my studies. There is a statement by Viju which is repeated by her lawyer, which is Viju's word against mine, that I had mental health difficulties in the US my father had to rescue me. This is a gross perversion of the truth. Again my statements are not proved nor are Viju's, and all we have are these statements.

If my father made hundreds of phone calls (as he had done before) to offices in Ireland, it would have potentially sabotaged my immigration case. In those calls, he would go over "mentally mentally mentally". I just didn't want that to happen he's done it before.

However I did make a video in memory of my mother on YouTube, and I did send it to my father. Youtube records the dates when videos are made and that was made in March 2022

So that is not true that I did not feel sorrow or do anything about my mother's passing

But I did phone the Royal Berkshire Hospital Bereavement office at the time she died, and it turns out that Viju Wortley has given them very special instructions not to divulge a little bit of information. This was apparent from their attitude over and above not being able to give information because I'm not the executor. They had an attitude, and they had logs that I should never have that information -I can explain further.

YEAR OF FATHER'S DEATH

My father had said in 2024 January and February that he needed my address to include me in his will. He did not tell me he had excluded me but he seemed very caring and affectionate. I cannot say it was fake.

18.01.2024

My birthday card for the 18th of January had not reached and I sent a second card which also did not reach by the 18th of January. So on his 90th birthday, I told my father I was sad that he did not get my birthday card on time. He said it doesn't matter if I never see your birthday card, because I know of your good intentions

The following morning he had called ambulance he was in hospital for 3 days and Viju Wortley had driven him back to 19 Carston Grove. We were speaking every day on WhatsApp but he stopped responding on the 22nd of January 2024.

Of course I was very worried that he might have passed away but I wouldn't tell my father I was worried that you would pass away because that would upset him I didn't want to tell him about. I am very affectionate and sentimental by nature.

25, 26 January 2024 EXHIBITS 2 SMS FROM DAD AND 1 FROM BASINGSTOKE POLICE

My father sent two text messages from his phone to me saying he was on a holiday in Cornwall. I have saved the 2 sms which are date stamped. The two SMS said when he was alone in 19 Carston Grove we could chat on WhatsApp.

I also have an sms date stamped to exhibit, which is from Basingstoke police whose help I enlisted to locate my father, who was not in Royal Berkshire Hospital or Basingstoke Hospitals they confirmed. The Basingstoke police had said they would not do a live-and-well check on my father by visiting Viju's home (since I could not contact her). They however checked with the ambulance service and told me that no ambulance had been to the Wortleys' residence. My father had not been collected alive or dead from their residence.

After returning from his Cornwall holiday which my father had had with Viju and Steve, they had brainwashed him to swear that he never went to Cornwall, and he also repeated **“the atomic weapons in their wisdom have asked you to stay out of the UK forever.”** Earlier, he had said it would be nice to have me by his bedside.

My father stopped replying on WhatsApp on the 23rd of March 2024. On 28th March 2024, Kennet Valley Free Church visited 19 Carston Grove and Mrs Tidbury from House

no 20 (20 Carston Grove) told pastor that my father was staying with Viju Wortley.

Hated by some UK men

I want to state in March 2024 I started to get 100s of calls to my UK mobile. I retained my UK number -not currently-after leaving the UK in April 2018, Lebara did not charge for roaming. The men mostly English were calling at 2am and saying instead of hello , "what is your name? What is your address? Etc". No I don't give out my information. But these calls were apparently from a heavyweight boxers escorts agency. My number was compromised by my Adpost ad for the Reading area, asking if anyone could help locate unwell 90 ys father. That is how I got one response from a Tamilian John Stephen.

On 24 April 2024, a Tamil speaking man John Stephens in Reading, agreed to visit my father if he would speak in Tamil. I said he would. I paid the taxi fare and John went to Viju's home and he found that they were not at home there was a large dog barking from inside. He connected the WhatsApp to me so I could hear the animal, and he wrote a note which he also gave me a copy of; he put it under her door that he wanted to speak to my father. I understand that John has gone back to India with his family, Viju failed to reply to John while realizing I was so worried about Dad.

April 2024

Anyhow I sent 2 registered post letters of identical content on 19th of April 2024 addressed only to Mr Venkataramanan, One copy to Mala which is Viju's home, the other to 19 Carston Grove. The one sent to Mala, was refused and returned to Sender and it was signed VW. The other one at 19 Carston Grove was signed foreign accepted by somebody impersonating my father.

May 2024

I sent this same letter Again by registered post to 19 Carston Grove on the 8th of May. This time it was signed and accepted by someone else impersonating my father. One of them called themselves Krish. My father has never called himself Krish although some people called him that. No handwriting match. Would appear that Viju or her friends impersonated my father. Wanted me to think he was still living at 19 Carston Grove,

I suppose she did not want me to know that my father was living with her,

I used a mailbox company in Dorset, when I sent these three Communications, to make it easy for the recipient, to return to Sender if they should be so inclined. This company has been praised in the newspapers so they have a great reputation.

The secretary at Theale Medical Practice where my father was registered told me in March or April of 2024. that it was illegal to disclose to me whether my father was alive or dead. This is absurd just because I'm not named as the executor of the will.

May 2024

Basing stock police told me in May 2024 the Hampshire County Council were the best people to get in touch with if I wanted to know about my father's health status. The latter kept on lying to me that somebody was going to get back to me. I made a complaint to Hampshire County Council which became official on July 25 2024. I have these correspondences and I am not legally qualified.

July 2024, 2 August 2024

The Hampshire County Council lied to an official in Hampshire around 2 August 2024 that my father was discharged, or about to be discharged from Ashton-Barchester Nursing Home and not clear where to. The truth was that my father had been admitted to that Nursing Home (date unknown) and discharged to Basingstoke Hospital on 20 July 2024, and passed away there on 1 August 2024. They (council) must have known my father was no more when they said this to the Hampshire official

2 August 2024 ham live-and-well check

A an elderly Indian ham a crony of my father visited 19 Carston Grove on 2 August 2024, after I phoned Hampshire RSGB Radio Society of Great Britain about not knowing Dads whereabouts. The ham reported, which was emailed by the RSGB Hampshire coordinator, the house had been emptied and it looked like nobody had lived there for a while . A next door day lady (there is only one physical neighbour to 19 Carston Grove. That is house no 20 -Mrs Tidbury, because 18 Carston Grove is on the other side of the road) told the old ham my father was staying with Viju and one of them would get in touch with her.

Did Mrs Tidbury not know my Dad had died the previous evening?

News of death

On 9 August 2024, I received email from Hampshire County Council with condolences. They said they had to disclose the death, because of my complaint.

Personally, I feel Viju lacked warmth. Mother (Radha) always said Viju was abusive to her, while sucking up to my dad who had 100% control of money matters. According to funeral directors Alexander and Dry, after my father died 1915 hours, she and Steve did not see the body instead had a fully unmanned operation. They had an unattended funeral in the wee hours of the morning 8 August 2024. This was allegedly the cheapest funeral available in the UK. Then she paid and collected the ashes, they said. Viju was perhaps trying to save money.

Did Viju exert undue influence?

Perhaps Viju had influenced Hampshire County Council not to disclose about my fathers death until after the funeral. Perhaps Viju raised the alarm to the Theale Medical Practise, my fathers GP's surgery, and the RBH bereavement office I was some kind of high risk demon and my fathers death was to be kept secret.

The late Venkataramanans and their two offspring, Mohini and Vijayalakshmi are an upper middle class Indian high caste family, and as commonly happens, highly dysfunctional as a family.

Viju knew Alex McDowell's address and phone. My father probably gave her my Dublin address before he died. Mrs Slade (House#18) and Mrs Tidbury(House#20) knew Alex's address and phone as well as my Dublin address and phone at the time of my fathers death. She had all the above methods, and the Basingstoke police as ways to contact me if she wanted to give fathers will or notify of his funeral. She chose to never tell me if not forced. What people don't seem to understand is that is morally wrong to hide info of my fathers death from his own child, just because of stories and allegations about my mental state. Think of the distress it would cause me. I have a human right to know of and attend my parents funerals
