# CANNOT FIND OUT IF FATHER ALIVE OR DEAD

Firstly I have an emergency problem and this is not an immigration matter, but goes to explain why I am refused like this. I want to ask you in 1 sentence, w/o wasting time, if you have suggestions to improve this matter.

Everything I discuss with you is confidential, and I want you to discuss it with no one except Alex if you feel it is injurious to my case.

Part of my desire to come to the UK is to visit my father, who is likely to die before a visa application has time physically to be successful. Now I want to keep in touch with my father on mobile/WhatsApp daily, which has become difficult since the start of the new year 2024 when he turned 90, and his health started to decline so he could no longer stay in his home at 19 Carston Grove West Berkshire district and went to stay with my sister Viju and brother in law Steve Wortley around 10 miles away in Tadley, Hampshire district off and on.

My father is physically under my sister's control and it is not clear how she restricts his phone use. I can see she does not want Daddy to speak to me. Today is April 28, 2024, for over a month his phone has been dead. I am sure my sister will not be informed if Daddy dies.

This is very distressing. I cry a lot about this. I must have a legal right to know if Daddy dies and if not, to know about his condition and to talk on the phone if he is alive and conscious.

My sister has a trumped-up criminal conviction against me called harassment without violence dated 8 July 2013. It was not done in a proper way, and I was not given appeal rights. This expired in 2018 however she told my father – when he was in better health- that she would not withdraw the injunction for life to not contact her. The Basingstoke police reckoned I should be able to contact Viju via Facebook under the circumstances.

So far Viju's husband has (2024) made up lies and threats to Alex McDowell, and did not answer the door when an Indian friend visited Viju to do a live and well check on Daddy.

I have also attempted to contact my fathers neighbors at 18 and 20 Carston Grove, who are unhelpful, and they are I assume, pretty close to Viju Wortley

Finally, the NHS surgery where my father is registered-their secretary said she cannot tell me if my father is alive or dead-I doubt there is a law to conceal such information

So far my father's Councillor and a Christian pastor have tried to help me find out if my father is alive or dead.

I am struggling and Basingstoke police said to talk to social services

What have I done since the 2 visa refusals.

**The home office have kindly provided a 4,000 page document Subject Access Request, Criminal checks UK IE -USA Canada in motion**

**criminal record check-**

**AM I A BAD CHARACTER?**

As you said you may find nothing in the refusals giving an item to appeal. I have obtained a criminal check from ACRO UK police 2004-2018 and Ireland 2018-2024. This proves that I have in the 20 years I don't have any criminal record in the UK or Ireland.

I have also tried to find a method of getting thorough exhaustive criminal checks from the USA and Canada to account for most of my life there is no criminal record but this one with my sister.

The procedure has been confusing with the FBI wanting fingerprints and state or federal records and I 94 in the USA. I may need professional help to do a criminal check USA. Canada not yet but intended.

**Mental health reasons:**

The first visa refusal may say I may run away from Alex due to mental health reasons. I am registered disabled from heart failure and should not be able to get very far should I be crazy enough to run away. I should not need to run as I have a safe place to stay in Ireland. I have lived at the same address for 2 years 8 months in Ireland.

As the negative is difficult to prove, you will find the Home Office does not have psychiatric records other than 1 done by Duncan Lewis Solicitors in 2011 and 1 defense report done under Rashid Solicitors in 2015. I was briefly sectioned in September 2014 for 2-3 weeks as I deliberately tried to avoid a deportation date.

During these 14 years, I did not receive any psychiatry other than the above-mentioned. There has however been a hullabaloo and talk about mental health problems treated by the Pembroke Mental Health Centre. I never engaged with them and based on the allegations understood they may have maintained fraudulent records of me taking treatment.

I have been in and out of hospital in Ireland and psychiatry has never been brought up by umpteen consultants.

# Institute of Physics

I was expelled from the Institute of Physics membership for bringing them into disrepute in 2006. Alex works for them unpaid as it is useful in ones CV. I understand, but feel they are not honest people, and have a legal right to practise racial discrimination as a Royal Society. I was expelled over their woman policy and feel up to date, the institute has few or no people from the Indian subcontinent as members so maybe this policy is unsuitable for these races. A lawyer speculated my strange incidents and intent to deport could have been instigated by Institute of Physics who he said can be behind my denial of working rights.
