Dear Mr. Abu

I just wanted you to know that the criminal conviction took place in July 2013, but in 2010, and 2011, my father, resident in RG317ZN made a malicious referral to mental health services under the premises I was a missing person therefore mentally unstable. There is a police email about the missing person report, and a letter from Pembroke alleging my father made a referral to them. This is one of the unusual and unfortunate things about my life history that my parents did things like that. Naturally with Alex as my only counsellor I do not tell this to anyone, as my visa application is supposed to be to visit father. Which I have wanted but there has been a serious problem between me and my parents.

To substantiate the mental health referral my father used a false premise that I lived with him and my mother. He used an Indian PC in his area Thames Valley, to make this report, The latter emailed me then "went on long leave".

All the time, my father knew I was safe and sound at Alex's.

My mother did not like me with any guy and used to hate my former husband Mr Hersom when we were married. She told Alex stuff about Viju's kids and told him not to tell me. Viju made out to my mother I was a devil who should not know about her kids. My mother acted as Viju wanted and told Alex the girls' school was top secret from Mohini. I got mad and did social engineering to find Viju's girl's school. I had an affectionate attitude towards them. I did not blame the kids for their parents' behaviour.

If you look at the submissions of Viju Wortley civil, criminal you see several submissions of my notes that are not addressed to Viju Wortley and are not about her. They don't amount to anyone's harassment except that the police hacked me and obtained these communications. People don't like what I said (politically incorrect)in them but they have nothing relevant to the harassment of Viju Wortley. I was feeling tortured over men from Pembroke kicking the door often after Alex went to work. UKBA unlawfully broke his door leaving his home unattended had he not arrived early by coincidence. We had been through hell, I was angry. I took an overdose too in 2011& had a heart attack. Viju's submissions are not related to her charge or her or her family in any way. The exhibits only show what a "crazy horrible person" I am, to

crowds that would hate me. I am hated even today and someone in the UK has entered my UK phone into an escort service and I get ugly calls from men in 2024, 100s.

I only called Steven Wortley a bastard one time in an online communication, and subscribed him to receive newsletters belonging to a Quran and British national party and Steve hates both. Harassing that lady and kids NEVER HAPPENED. Telling Pembroke I want to harm Vijus kids NEVER HAPPENED. VERY MALICIOUS. When I get spam newsletters I delete them. Men don't receive a life sentence for calling someone a bastard.
