WHAT TYPE OF EVIDENCE DO I HAVE?

One evidence I have is legal letters and emails received from the courts or solicitors, as well as ones I sent them.

Unfortunately I did not understand legal processes at that time as well as I do now, and did not use formal means to send communications to Ally Lindsay solicitors. I made some foolish botch-ups and did not covertly tape Ally Lindsay Solicitors, or
