Mr. Butler was skeptical that a mental assessment would be carried out by anyone but a nurse, as he has participated in such procedures.

A different person I saw in London required a tape of my solicitor, Mr. K (who was Indian) explicitly proving he pressured me into a guilty plea.

This is a mess but I feel there are at least two communications from the solicitor confirming he was keen I plead guilty although

may not be a strong enough proof to complain about him

In the chargesheet, or whatever you call it, I have gone into detail in scrawly handwriting nonetheless this should probably be added to the guilty plea. It is evidence of my detailed statement to police

It says what I did as opposed to what Viju and Steve say I did. I never targeted women and children but called Steve a bastard.

The solicitor Mr K also made me feel bad about telling my father he was a bastard in 2010 after he made a malicious referral to mental health services and a bogus missing person report of self using an Indian PC of Thames Valley Police to whom my father lied I was living with him and my mother. He said to say only one word GUILTY. Promise to follow my instructions EXACTLY.

I did not know about the procedures like going on trial and pleading guilty even after pleading guilty. They said your case won't go on trial and I asked what exactly does that mean.
