What I know about my parents assets

My father was in the government of India in a pharmaceutical company. He also did an international pharmaceutical business. I was kept in their Delhi home against my will, which is a long story. At that time, I saw people coming in to make payment with suitcases full of currency notes, even gold coins. So he did a lot of importing and exporting of pharmaceuticals.

My father retired around 1991 or 1993 for health reasons. I left India and went to Canada in 1995. I was physically deported to India in 2004. At the time, my parents had sold their house in Delhi and bought a house in Madras. They had also inherited a house from maternal grandma. It was a big bungalow with a proper garden around it. They sold that for 400k pounds. Then paternal grandma also died and left my father 0.1 million pounds in cash from my late grandfather's real estate business.

In 2006, my parents bought the present house where they lived until they died. They also came here on a wealth retirement visa. They had to show proof of income of 11,000 pounds per year to be eligible for the visa. My father said he had accounts that were given him interest in excess of 11,000 pounds per year. Alex and I stayed overnight with Mom and Dad around 2018 and found one account in India with 0.1 million pounds, and they also had private banking with Natwest and HSBC. My mom had the same caste really (South Indian lady) relationship manager who could speak our language.

My mother said she gave most of her gold and diamonds to Jasmine, my niece. She saw the rest of the diamonds and some ivory statues she had inherited at Sotheby's and Christie's auctions.

In 2015, I stayed with mom while my dad went to India along with my brother-in-law, Steven Wortley. It was to sell the flat in India that they had abandoned when coming to the UK. My father was not well enough to travel alone.
