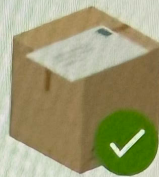
She lives in her own home with Mr

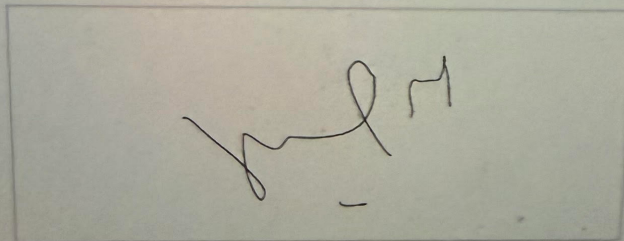

Tracking history

Dear Mr Abu

It appears you have mistyped Viju's postcode as shown in the Royal Mail slip you have sent today of letter#3 sent 27/01/2026.. The correct postcode is RG263PA and not RG266PA. This may be why the mail was not delivered.

I am not sure if you used this wrong postcode, RG266PA in all 3 communications.

However, there is evidence the Wortleys signed for the letter#1 received 2025-10-08 because the signature is like the ones obtained on registered post addressed only to Mr. K Venkataramanan on 2024/04/24 to Mala (signed, returned to sender) and on 2025/05/11 to 19 Carston Grove (same signature and accepted). I feel a handwriting expert would say the 3 letters were signed by the same individual, who according to me is Mrs Wortley. This signature looks like a W while the earlier ones like V W, my naked eye makes me sure the strokes are by the same hand, so all these mails were signed by VW.

I don't know if you feel there is sufficient evidence Viju rejected the second communication which was returned to sender

Alex worries about this matter.

Alex said you also sent copies to Viju Wortley at 19 Carston Grove as well. He is unsure if you sent all 3 communications by recorded delivery (signed for). Did you send 1 to 3 of these to 19 Carston Grove and what happened?

Because a mistake has occurred, purely clerical, Alex and I fully trust your professional expertise to do whatever it takes to remedy this clerical error so we don't lose in any way.
